



Qualifying Instructions to do the Summer School of Project VIPSKILLS

Among Students of Vilnius College Technologies and Design

- 1. Applications for the project will be collected from 15 February 2018 to 15 March 2018.
- 2. Information about the enrolment and rules of qualification process will be available on webpage of Vilnius College Technologies and Design http://www.vtdko.lt/index.php/studentams/sf/aktualu/1923-projekto-virtual-and-intensive-course-developing-practical-skills-of-future-engineers-stovyklos-studentams
- 3. The candidates should have completed at least four semesters of study in *Degree of* Professional Bachelor in Building Services Systems;
 - Professional Bachelor in Structural Engineering;
 - Professional Bachelor in Thermal energy Engineering
 - Professional Bachelor in Renewable Energy Engineering
- 4. Qualifying Committee consists of the following members:
 - Lina Sakalauskienė;
 - Kęstutis Jasiūnas;
 - Zita Bražiūnienė.
- 5. The work of Qualifying Committee is chaired by a Team VTDK Coordinator.
- 6. The tasks of the Qualifying Committee should be:
 - 1) to carry out the qualification procedure.
 - 2) to respond to-date on e-mails candidates throughout the qualification period,
 - 3) accepting documents of candidates,
 - 4) deciding on eligibility / not qualify,
 - 5) preparation of documentation from the procedure,
 - 6) contracts to participate in the project.
- 7. Qualifying Committee works according with the schedule attached to Instruction (Annex.1).
- 8. All changes to the schedule are posted on the website of Vilnius College Technologies and design: http://www.vtdko.lt/index.php/studentams/sf/aktualu/1923-projekto-virtual-and-intensive-course-developing-practical-skills-of-future-engineers-stovyklos-studentams
- 9. Team Coordinator is responsible for proper and timely execution of tasks corresponding to Qualifying Committee.
- 10. Enrolment of candidates starts from signing up at the project website www.vipskills.pb.edu.pl.
- 11. Confirmation of registration is the return e-mail with Application Form
- 12. Student delivers printed, filled and signed Application Form to the Team Coordinator no later than 15 March 2018, 12 pm.
- 13. Qualifying Committee qualifies for the first stage only candidates who have delivered a signed paper copy of the form according to rules:
 - 1) average mark of transcript of records (max 60 points)
 - 2) average mark of specific following subjects connected with Summer School (max 10 points):
 - Renewable Energy;
 - Energetics Systems Control;
 - Efficiency of Energy Consumption;
 - Solar Energy;





- Wind Energy;
- Hidroenergy.
- 3) English language max 10 points:
 - certificate level C1: 10 points
 - certified level B2: 5 points,
 - certificate level B1: 3 points
- 4) Courses, scientific and organization activities, membership in Student Associations max 10 points (2 points for every form of activity, eg. Courses, Business in a circle research, participation in conferences, etc.)
- 6) Additional information about student- max 10 points possible to grant the Qualifying Committee on the basics of interests, motivation to participate in activities, ideas for the contribution of the candidate in the organization of the Summer School, etc., interview
- 14. The Qualifying Committee reserves the right to conduct interviews with candidates to discuss details from the applications and verify the practical conversation skills in English. Information about the interview will be given to candidates by e-mail.
- 15. The Commission based on the number of points awarded to individual candidates establishes an initial list of qualified students.
- 16. Eligible to participate in the project is 8 students.
- 17. The date specified in the schedule (annex.1), the preliminary list qualified to participate in the project candidates will be known together with the total number of points obtained. In this list, the preliminary 8 selected students will be indicated, as well as the students in reserve and those excluded.
- 18. The number of points awarded for each student in each criterion is available for consultation at the Office of Civil Engineering Faculty within 2 working days from the announcement of the preliminary list of qualified candidates.
- 19. In the case of ineligibility to the project applicant is able to appeal the decision of the Qualifying Committee within 2 working days from the announcement of the preliminary list of qualified candidates.
- 20. Appeals with justification must be submitted to the Team Coordinator.
- 21. Appeals and any disputes shall be resolved by Qualifying Committee within 2 working days.
- 22. After the appeal process the final list of qualified to participate in the project shall be available in webpage EPSB and in the bulletin board of this School,
- 23. In case of unforeseen resignation of students qualified to participate in the project the reserve list is created.
- 24. The result of completed qualification process is documentation (reports, minutes of meetings of Qualifying Committee; list of candidates under consideration qualifying list of qualified, the reserve list etc.)
- 25. Within 14 days of the publication of the final list of qualified candidates students are obliged to sign contracts to participate in the project. Failure to sign the agreement prevents participation in the project.
